


Interagency Referral Pathway – MSCB ‘Serious Case Review Sub-Group’



Interagency Referral Pathway – MSCB ‘Serious Case Review Sub-Group’

The case gives rise to concerns about the way in which local professionals and services worked together to safeguard and promote the welfare of children. This includes inter-agency and/or inter-disciplinary working.

If the Sub-Group decide that the criteria for a Serious Case Review is met they will make a recommendation to the Independent Chair of Manchester Safeguarding Children Board.
